

# Instructions for Making a Donor-Advised (DA) Contribution

# MAKING A DA GIFT THROUGH NIF IN THE UNITED STATES (MINIMUM DONATION: \$100)

NIF US covers all fees and costs of DA donations as part of our mission to support Israeli civil society.

**Checks** should be made payable to "New Israel Fund" and mailed to New Israel Fund, PO Box 70358, Philadelphia, PA 19176-0358. If the check must be mailed to an office, please contact <a href="mailto:DAGifts@nif.org">DAGifts@nif.org</a>. Please write "donor-advised to [grantee name]" in the check memo/cover letter/both. There is no need for multiple checks; one check can be used for multiple donations.

**DAF gifts:** If making a DA donation/s through a Donor Advised Fund, please include instructions on the allocation/s, or notify us of the allocation/s by emailing <a href="mailto:DAgifts@nif.org">DAgifts@nif.org</a>.

**IRA gifts:** Please ensure that your name and the allocation/s are included on the check. More info on IRA gifts can be found at www.nif.org/ira.

**Online gifts**: A limited number of grantees have dedicated online donation pages on the NIF <u>website</u>. Due to the expense entailed, NIF does not currently accept DA donations by credit card, aside from through these donation pages, and <u>donations are capped at \$5,000 each</u>; larger gifts can be made by check, bank transfer, etc. Donors have the option to cover credit card and transaction fees (approximately 3%).
